The following resolutions have been adopted unanimously.

1. The Committee decided to go for re-tender of the patient diet with Catering Services at JMCH, Jorhat, as per minutes of the meeting dated 26-04-2018. Accordingly the following schedule was adopted.
 - a. Uploading of E-Tender – 03-05-2018
 - b. Last Date of Submission of E-Tender- 24-05-2018 at 12 Noon.
 - c. Technical Bid opening of E- Tender-24-05-2018 at 1P.M.
 - d. Financial Bid opening of E-Tender- 28-05-2018 at 1P.M.
2. There should be wide publication of the Notice Inviting Tender
 - a. One National News Paper (The Telegraph).
 - b. Two local News Paper one English (The Assam Tribune) and one Assamese (The Dainik Janambhumi).
3. As there was only one bidder participating in the earlier Tender processes the Committee has decided to slightly modify the Tender so as to attract more number of participants. Hence a corrigendum to be floated along with the re-tender as follows.
 - i. Minimum requirement criteria clause D in the bid document is to be omitted.
 - ii. Minimum requirement criteria in clause J "The bidder must have adequate experience of execution of similar work in Govt. Medical Hospitals/ Govt. Civil Hospitals/ Govt. Establishment/ PSUs". may be read as "The bidder must have adequate experience of execution of similar works in Govt. Hospitals/Govt. Establishments/Public Sector Undertakings or similar organizations"

The meeting concluded with the vote of thanks from the Chairman.
