



Expression of Interest is invited from eligible firm for "**Repair and up-gradation of computer, Printer, UPS etc. at JMCH**". Interested parties/firms may contact in the O/o. Superintendent, JMCH, Jorhat for **Technical Survey** which to be repaired during office hours and submit their proposal in the form of quotation affixing court fee stamps of Rs. 8.25/- (Rupees Eight and Paise Twenty Five) only on or before **18/05/2021** up to **12.00 P.M.** The EOI will be opened on the same day at 1.00 P.M in presence of the quotationer or their authorized persons. The proposal should include all the required documents like GST, Trade License, PAN etc. for consideration.

Documents to be submitted along with Quotations:

1. Up to date Trade License
2. PAN
3. GST Certificate.

Terms & Conditions:

4. All the papers of the quotation must be signed with date.
5. The firm should provide the part/items with warranty. In case of any defect noticed in the item during a period from the date of installation, the items will be replaced with new one immediately without any extra cost.
6. Only branded spare parts should be used.
7. The payment will be made only after satisfactory installation of items after satisfactory installation/working report is received from the end user.
8. The machines are normally required to be repaired in the office premises within 3 (three) working days from the date of receipt of supply order. In exceptional cases when the machine cannot be repaired in the office premises and repaired to be taken to the workshop, deptt. will not make any payment towards cartage and the expenses for the to and from transportation of the machines should be borne by the firm.
9. Bidder should submit the technical proposal in a sealed separated enveloped after **technical survey**. A closed tender will be floated amongst the selected bidders. L1 will be selected on the lowest approx. estimated value per machine quoted by the bidders.
10. The empanelment shall be valid for 1 (one) year. The empanelled firm will visit JMCH as per time to time requirement by the authority.
11. The JMCH reserves right to reject the lowest or any other tender without assigning any reasons thereof.
