- 1) SUBMISSION OF PROPOSAL: The interested bidders should submit their duly sealed EOI on or before scheduled last date containing all the Annexures containing desired information. A signed copy of this EOI shall be submitted along with the technical proposal as a token of acceptance of EOI terms & conditions. The proposals should be signed by the authorized representative/s of the Agency. The agencies who wish to submit responses to this EOI should note that they should abide by all the terms and conditions contained in the EOI. If the responses contain any extraneous conditions put in by the bidders, such responses may be disqualified and may not be considered for the empanelment / selection process.
- 2) SCOPE OF WORK: The scope of work shall be supply, installation and commissioning of IP based CCTV Surveillance System of latest and appropriate technology at various vital points of the institute (outside of the JMCH campus). This is to be noted that the proposed system has to be integrated IP based system for centralized monitoring.
- 3) **ELIGIBILITY/OUALIFYING CRITERIA:** Following are the qualifying criteria for the interested bidders for consideration of short listing for further process:

 - iv). Annual Turnover certificate of Rs. 10,00,000/- (per year) for last two assessment year authenticated by the Charter Accountant.
 - v). IT return acknowledgement for last two assessment year.
 - vi). Should not have been black listed by any State Government, Central Government or any other Public Sector undertaking or a Corporation as on the date of EOI submission. An undertaking to this effect should be submitted by the Agency on its letter head.

- vii). The bidders should be OEM or its authorized agent.
- viii). Should have executed considerable amount of work in similar filed i.e. IP based surveillance system with Centre/State Govt. organizations/ reputed private companies.
- 4) <u>SITE VISIT BY THE INTRESTED BIDDERS</u>: Before submitting the EOI, the interested bidders are advised to visit the actual site and satisfy themselves about actual scope of work, conditions. Interested parties shall be deemed to have full knowledge of the site whether they inspect or not hence no misunderstanding whatsoever shall be entertained at later stage.
