## **TERMS AND CONDITIONS**

1. The Tenderers should be registered firm under GST Act.
2. The quoted rates should be inclusive of all taxes except GST  
The GST charges should be mentioned separately.
3. The delivery of the items should be made to the JMCH Blood Bank in fresh & good condition.
4. Any conditional tender will not be accepted
5. No advance payment will be made against execution of orders.
6. The rate should be valid up to one year from the date of finalization of the tender.
8. **2 Nos. of Samples MUST be submitted before the committee during BID opening.**
9. The tenderer shall sign all the pages of tender & the rates of the items should be quoted both in figures and words against the items to be shown by the bidder in price bid.
10. Original documents may be produced for verification, if necessary
11. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or incorrect their tender will be cancelled.
12. The tenders should be furnished within time frame duly sealed super scribing "TENDER FOR SUPPLY OF INDOOR REFRESHMENT (FOOD) ITEMS FOR BLOOD BANK, JMCH" on the envelope.
