

The lowest tender price shall be subjected to the minimum fees as provided in the tender document.

In case of total highest score of two or more bidders is found to be equal, the work will be awarded to bidder who have longer experience in the conducting audit

#### AWARD OF CONTRACT:

The initial period of contract shall be for 1 year which may be further extendable upto 1 (one) year at a time, depending on performance of the Agency/Firm/Company and at discretion of JMCH authority.
