- 1. The Tenderers should be registered firm under GST Act.
- 2. The quoted rates should be inclusive of all taxes except GST

The GST charges should be mentioned separately.

Any conditional tender will not be accepted

6. No advance payment will be made against execution of orders.

- 7. The rate should be valid up to one year from the date of finalization of the tender.
- 8. Selection of items may be made by examining the samples items, whenever necessary

## 9. 2 Nos. of Samples MUST be submitted before the committee during BID opening.

- 10. The tenderer shall sign all the pages of tender& the rates of the items should be quoted both in figures and words against the items to be shown by the bidder in price bid.
- 11. Original documents may be produced for verification, if necessary
- 12. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or incorrect their tender will be cancelled.

- f) EMD of Rs. 2000/- (two thousand) only in the form of 'Demand Draft' in favour of "JMCH TENDER" payable at Canara Bank, Jorhat Branch.
- g) The bidder must quote rate of all the items within total of Rs. 25/- only.
- h) Only the lowest quotations will be accepted and supply order will be given accordingly.
